SECTION 4: First aid measures

4.1. Description of first aid measures

Generally

SECTION 5: Firefighting measures

5.1. Extinguishing media

Recommended extinguishing agents

Extinguish with water mist, powder, carbon dioxide or alcoholresistant foam.

Unsuitable extinguishing agents

May not be extinguished with water dispersed under high pressure.

5.2. Special hazards arising from the substance or mixture

Gases detrimental to health (carbon monoxide and carbon dioxide) can be spread in case of fire. The gas forms an explosive mixture with air. Aerosols may explode when heated to temperatures above 50°C.
